CALL TO ORDER/ PLEDGE OF ALLEGIANCE /ROLL CALL

President Peter Mallek called the meeting to order and the pledge of allegiance was recited.

President Peter Mallek introduced Attorney Brian Formella to the group present tonight.

Attorney Brian Formella spoke saying that the Board will take no action on any proposal tonight for the sale of Pamaron Subdivision. While the Village wants the subdivision to succeed the Village will need some assurances before anything is signed.

Mr. Ontiveros Zamora does have a legitimate concern about the liquidated damages – that being 6 houses not built since the subdivision started. He does not want to assume this liability.

Attorney Formella requested that Mr. Ontiveros Zamora provide the Village with his marketing plan in writing with some financial information for the Village to consider. The Village will need to feel comfortable with Jorge's plan going forward. The Village would like him to succeed but we also have an obligation to the taxpayers in the Village of Junction City. We need to see a viable plan from Mr. Ontiveros Zamora.

Next tentative meeting is scheduled for Wednesday, May 25th giving Mr. Ontiveros Zamora time to provide the Village with his marketing plan.
